1. NO PURCHASE NECESSARY TO ENTER OR WIN THE PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. A TWITTER ACCOUNT AND INTERNET CONNECTION ARE REQUIRED FOR ENTRY. VOID OUTSIDE OF THE FORTY- EIGHT CONTIGUOUS UNITED STATES AND DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

2. Eligibility: This Sweepstakes is open to individuals who are legal residents of one (1) of the forty-eight (48) contiguous United States or the District of Columbia who are at least eighteen (18) years of age at the time of entry. If a participant is at least eighteen (18) years of age but deemed a minor in his/her jurisdiction of residence (**"Minor"**), he/she must obtain parental/legal guardian consent prior to entering the Sweepstakes. There will be one (1) grand prize winner (the "**Winner**") selected at random by Sponsor from among all Eligible Entries received for each individual Sweepstakes within approximately three (3) weeks of the close of the applicable Entry Period for a total of three (3) Winners. Sponsor reserves the right to select an alternate Winner in the event that an originally selected Winner fails to comply with these Official Rules.

Sponsor will make up to one (1) attempt over a twenty-four (24) hour period following each potential Winner's selection to contact such potential Winner via direct messaging to potential Winner's Twitter account and via tweets from Sponsor's @thehills Twitter handle. If a potential Winner cannot be reached directly during the twenty-four (24) hour period in which he/she is being contacted, such potential Winner will be disqualified and an alternate Winner will be selected at random from among the remaining applicable Eligible Entries received. This process will be repeated until a potential Winner responds, as time permits, in Sponsor's sole discretion. Sponsor reserves the right to select an alternate potential Winner from among the Eligible Entries received in the event that a potential Winner fails to comply with these Official Rules.

7. Winners' Verification: Time is of the essence in awarding the Grand Prizes. As such, the potential Winners must prove eligibility, including, without limitation, proof of age and residence, phone number, social security or resident alien identification number, within forty-eight (48) hours of being notified as potential Winners. alternate potential Winner may be chosen from among all of the remaining Eligible Entries received, if time permits, in Sponsor's sole discretion. 8. .Grand Prizes (3): Each Winner will receive a trip for two (2) to Los Angeles, CA. Each trip includes: (a) round-trip coach airfare for Winner and his/her one (1) guest (who must be at least eighteen (18) years of age) (the "**Guest**") between a gateway airport in the forty-eight (48) contiguous United States nearest Winner's primary residence and Los Angeles, CA (if Winner resides within a one hundred fifty [150] mile radius of Los Angeles, CA, airfare for Winner and Guest will be replaced with ground transportation) and (b) three (3) nights hotel accommodations at a hotel in Los Angeles, CA to

be determined by Sponsor (which includes one [1] standard room based on double occupancy, room and tax only) (the “**Hotel**”) (collectively, the “**Grand Prize**”).

If a Winner resides in a jurisdiction that deems him/her to be a Minor, he/she must be accompanied by his/her parent or legal guardian who must be deemed the allotted Guest. If a Winner’s Guest resides in a jurisdiction that deems him/her to be a Minor, such Guest must be accompanied by his/her parent or legal guardian who must be deemed the Winner. If a Winner is a qualifying Minor, the Grand Prize will be awarded in the name of his/her parent or legal guardian. Prize fulfillment is subject to availability of services. The Grand Prizes may not be sold, traded, transferred, refunded, commissioned or redeemed for cash value elements may not be substituted by Winners. Sponsor reserves the right to structure travel routes and select hotels in its sole discretion. The ARV for travel prizes is an estimate made before the Sweepstakes begins. The Winners will not receive cash or any other form of compensation if actual travel costs are less than the estimate made in these Official Rules. The round-trip air transportation element for any travel prize begins and ends at the point of departure. No interest will be awarded on cash prizes. Room taxes and other hotel fees are not included and if applicable may be payable at the time of check-out by the winners/guests. A deposit or payment in advance, or presentation of a credit card by the Winners, may be required at the time of check-in at the hotel. Any hotel cancellations or changes to hotel reservations after confirmation must be made with the hotel directly, and the Winners are solely responsible for any charges and/or fees arising from changes made directly with the hotel.
