Official Voting Rules

These are the official terms and conditions for voting for "2023 MTV Movie and TV Awards" (the "Official Voting Rules").

VOTING STEPS

3. "POWER HOURS" AND "DOUBLE DAYS".

There will be designated "Power Hours" wherein the number of permitted votes will be increased from 10 to 20 per voter during those hours. In addition, there will be three (3) "Double Days" wherein the number of permitted votes will be increased from 10 to 20 per voter for a designated period during those scheduled days.
